8		subsequently amended and codified as 13 Tohono O'odham Code Chapter 1,
9		established the Tribal Employment Rights Commission ("TERO Commission") to
10		apply preference in contracting and employment under the Tribal Employment
11		Rights law; and
12	WHEREAS,	Section 1107 (H) of the Tribal Employment Rights law authorizes the TERO
13		Commission to "[e]xpend budgeted funds appropriated by the Legislative Council
14		for Commission operations" (13 Tobono O'odham Code Chapter 1); and
15	WHEREAS,	the TERO Commission has prepared and submitted for review and approval its FY
16		2020 Tohono O'odham Tribal Employment Rights Commission Budget, which is
17		incorporated by this reference, in the amount of \$107,335.91, which will be
18		funded by program revenues; and
19	WHEREAS,	the Human Resources Development and Budget and Finance Committees have
20		reviewed the FY 2020 Tohono O'odham Tribal Employment Rights Commission
21		Budget and recommends its approval.
22	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
23		FY 2020 Tohono O'odham Tribal Employment Rights Commission Budget
24		effective October 1, 2019 in the amount of \$107,335.91, which will be funded by
25		program revenues.
26	BE IT FINALL	Y RESOLVED that the Tohono O'odham Legislative Council authorizes the Tribal
