## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving Tohono O'odham Nation Long-Term Storage Credit Marketing Plan)

RESOLUTION NO. 19-372

1	WHEREAS,	"All waters which originate in or flow in, into or through the Tohono O'odham
2		Nation, or which are stored in the Tohono O'odham Nation, whether found on the
3		surface or underground, are a valuable public resource of the Tohono O'odham
4		Nation to be protected for the present and future use of the Tohono O'odham
5		Nation as a whole." (Constitution, Article XVII, Section 1); and
6	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Tohono O'odham
7		Legislative Council with "the control and management of these waters" and the
8		power to "[d]etermine how these waters shall be developed, used and conserved
9		for the greatest public benefit[,]" to "[e]nter into agreements, compacts or other
10		contracts for the beneficial use, sale, or lease or distribution of these waters[,]"
11		and "[t]o administer land and other public property, and by law, ordinance or
12		resolution to manage, protect, preserve and regulate the use of the property,
13		wildlife, land, air and natural resources (including surface and ground waters) of
14		the Tohono O'odham Nation." (Constitution of the Tohono O'odham Nation,
15		Article XVII, Section 2(a) and (b) and Article VI, Section 1(i)(2)); and
16	WHEREAS,	the Tohono O'odham Legislative Council is further vested with the power "[t]o
17		consult, negotiate and conclude agreements and contracts on behalf of the
18		Tohono O'odham Nation with Federal, State and local governments and other
19		Indian tribes or their departments, agencies or political subdivisions, or with
20		private persons or organizations on all matters within the authority of the
21		Tohono O'odham Council." (Constitution of the Tohono O'odham Nation, Article
22		VI, Section 1(f)); and
23	WHEREAS,	Tom Harbour of Headwaters Consulting, LLC has prepared a Long-Term Storage
24		Credit Marketing Plan for the Nation; and
25	WHEREAS,	the Water Resources Committee has reviewed the Tohono O'odham Nation Long-
26		Term Storage Credit Marketing Plan and recommends its approval.
27	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
28		Tohono O'odham Nation Long-Term Storage Credit Marketing Plan in
29		substantially the form presented to the Tohono O'odham Legislative Council in a
30		closed session held prior to adoption of this resolution, which shall be
31		maintained as a confidential document and not publicly disclosed.
32	BE IT FINA	LLY RESOLVED that the Tohono O'odham Legislative Council authorizes Tom
33		Harbour of Headwaters Consulting, LLC to market Long-Term Storage Credits on
34		behalf of the Nation, provided that any sales contract shall be submitted for
35		approval to the Tohono O'odham Legislative Council.
