

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Certification of and Distribution to A Tohono O'odham Nation Eligible**  
**Adult Member for the Second Per Capita Distribution for October 2019)**

**RESOLUTION NO. 19-392**

1 **WHEREAS,** on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the  
2 "O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes  
3 per capita payments to the Nation's members provided that sufficient gaming  
4 revenues are available; and

5 **WHEREAS,** the Ordinance for the Regulation of Gaming Activities Within the Tohono  
6 O'odham Nation (the "Gaming Ordinance") was subsequently amended to  
7 authorize per capita distribution payments in accordance with the Initiative  
8 (Legislative Council Resolution No. 97-303); and

9 **WHEREAS,** the Legislative Council did adopt the Second Revenue Allocation Plan and  
10 Amendment No. 1 to the Second Revenue Allocation Plan pursuant to Legislative  
11 Council Resolution Nos. 2000-269 and 2000-472, respectively; and

12 **WHEREAS,** on October 25, 2000, the Deputy Commissioner of Indian Affairs approved the  
13 Second Revenue Allocation Plan as amended; and

14 **WHEREAS,** the Tohono O'odham Nation Enrollment Office submitted to the Tohono O'odham  
15 Legislative Council the Certification of Eligible Members for the second per capita  
16 distribution for review and approval; and

17 **WHEREAS,** Legislative Council approved the Certification of Eligible Members for the second  
18 per capita distribution, with the initial number of 12,716 verified adult members  
19 (Resolution Number 2000-517); and

20 **WHEREAS,** the disbursement of funds to each eligible adult member is contingent upon  
21 verification of a member and certification by the Tohono O'odham Legislative  
22 Council; and

23 **WHEREAS,** the Tohono O'odham Department of Membership Services has submitted a  
24 certification listing of one verified adult member who is listed in the previously  
25 approved Certification of Eligible Members and is eligible to receive the second  
26 per capita payment.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council hereby:

- 28 **1. Approves the verification and certification of the adult member listed on the**  
29 **attached October 2019 Certification Listing of An Adult Member for the Second**  
30 **Per Capita Distribution.**
- 31 **2. Approves the distribution for \$2,000, less any applicable taxes required by**  
32 **federal law, to the adult member listed.**
- 33 **3. Authorizes the Chairperson of the Nation or a designated official to execute**  
34 **such other documents as may be necessary to implement this resolution.**

2 **funds to additional eligible Tohono O'odham adult members is contingent upon**  
3 **verification of membership by the Tohono O'odham Department of Membership**  
4 **Services and certification by the Tohono O'odham Legislative Council.**

5 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup>**  
6 **day of OCTOBER, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**  
7 **-0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
8 **Article VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
9 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
10 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
11 **18, 1934 (48 Stat.984).**
