## **LEGISLATIVE ORDER NO. 19-453**

1	WHEREAS,	the  Constitution  of  the  Tohono  O'odham  Nation  empowers  the  Legislative  Council
2		to "enact laws and ordinances for conducting and regulating elections" and
3		provides that the "decision of the Tohono O'odham Council in all election
4		matters, including the eligibility and qualifications of candidates, shall be final"
5		(Constitution, Article VI, Section 1(g) and Article X, Section 7); and
6	WHEREAS,	since May 2019, the Legislative Council alternate seat to San Xavier District
7		Representative Daniel L.A. Preston, III has remained vacant; and
8	WHEREAS,	pursuant to 12 T.O.C. Chapter 1, Section 1505(B)(3), when a Legislative Council
9		alternate's seat is vacant, a district may "adopt a resolution appointing an
10		alternate who shall hold office for the unexpired term of his predecessor;
11		provided that the alternate shall not be seated until the Board certifies in writing
12		that the alternate meets all the qualifications for that office"; and
13	WHEREAS,	on November 5, 2019 the San Xavier District Council appointed Racheal Vilson-
14		Stoner to serve as alternate to Legislative Representative Daniel L.A. Preston, III
15		on the Legislative Council (San Xavier District Resolution No. SXDC 11-19-01); and
16	WHEREAS,	by letter dated November 26, 2019, the Election Board has certified in writing that
17		Racheal Vilson-Stoner meets all the qualifications for the office of Legislative
18		Council alternate.
19	NOW, THERE	FORE, BE IT ORDERED that the Tohono O'odham Legislative Council recognizes the
20		San Xavier District Council appointment of Racheal Vilson-Stoner to serve as
21		alternate to Legislative Representative Daniel L.A. Preston, III and seats alternate
22		Racheal Vilson-Stoner, who shall serve in accordance with the Constitution and
23		laws of the Tohono O'odham Nation and with the rules and procedures of the
24		Legislative Council when Representative Daniel L.A. Preston is unable to attend a
25		Legislative Council session.
