

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Agreements)

RESOLUTION NO. 19-466

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "consult,**
2 **negotiate and conclude agreements and contracts on behalf of the Tohono**
3 **O'odham Nation with Federal, State and local governments and other Indian**
4 **tribes or their departments, agencies, or political subdivisions, or with private**
5 **persons or organizations on all matters within the authority of the Tohono**
6 **O'odham Council" (Constitution of the Tohono O'odham Nation, Article VI,**
7 **Section 1(f)); and**

8 **WHEREAS, the Tohono O'odham Nation has appointed an Economic Development**
9 **Delegation consisting of the Chairperson of the Nation and the Chairpersons of**
10 **the Tohono O'odham Legislative Council Commerce Committee, Agricultural and**
11 **Natural Resources Committee, and Budget and Finance Committee to address**
12 **issues relating to the Nation's ownership, use of, and the trust acquisition of the**
13 **West Valley property and additional issues related to the implementation of P.L.**
14 **99-503, including settlement negotiations; and**

15 **WHEREAS, the Economic Development Delegation has recommended that the Legislative**
16 **Council approve agreements relating to the implementation of P.L. 99-503.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **agreements recommended by the Economic Development Delegation**
19 **substantially in the form presented in closed session on December 17, 2019,**
20 **provided that such agreements shall not be reported or disclosed and shall**
21 **remain confidential.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH**
23 **day of DECEMBER, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
24 **-0- AGAINST; [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
25 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
26 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
28 **(48 Stat.984).**
