

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Department of Health and Human Services Division of
Senior Services Title VI Budget Amendments No. 1)

RESOLUTION NO. 19-467

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2020 Department of Health and Human Services Division of Senior Services
8 Title VI Part C in the amount of \$71,700.00; Title VI Part A Budget in the amount of
9 \$195,600.00; and Title VI Nutrition Services Incentive Program ("NSIP") Budget in
10 the amount of \$6,774.00 were approved by Resolution No. 19-162; and

11 **WHEREAS,** the Department of Health and Human Services ("DHHS") has prepared and
12 submitted for review and approval its FY 2020 Division of Senior Services Title VI
13 Budget Amendments No. 1, which are incorporated by this reference and which
14 will adjust operational and/or personnel line items; and

15 **WHEREAS,** the FY 2020 DHHS Division of Senior Services Title VI Part C Budget Amendment
16 No. 1 will increase the FY 2020 DHHS Senior Services Title VI Part C Budget by
17 \$43,069.18 from \$71,700.00 to \$114,769.18; and

18 **WHEREAS,** the FY 2020 DHHS Division of Senior Services Title VI Part A Budget Amendment
19 No. 1 will increase the FY 2020 DHHS Senior Services Title VI Part A Budget by
20 \$200,712.66 from \$195,600.00 to \$396,312.66; and

21 **WHEREAS,** the FY 2020 DHHS Division of Senior Services Title VI NSIP Budget Amendment No.
22 1 will increase the FY 2020 DHHS Senior Services Title VI NSIP Budget by \$5,426.03
23 from \$6,774.00 to \$12,200.03; and

24 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
25 reviewed the FY 2020 DHHS Division of Senior Services Title VI Budget
26 Amendments No. 1 and recommend their approval.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
28 FY 2020 Department of Health and Human Services Division of Senior Services
29 Title VI Part C Budget Amendment No. 1 effective April 1, 2019, which includes a
30 \$43,069.18 increase from \$71,700.00 to \$114,769.18; Title VI Part A Budget
31 Amendment No. 1 effective April 1, 2019, which includes a \$200,712.66 increase
32 from \$195,600.00 to \$396,312.66; and Title VI NSIP Budget Amendment No. 1
33 effective April 1, 2019, which includes a \$5,426.03 increase from \$6,774.00 to
34 \$12,200.03, all of which shall be funded by the Nation's general fund pending


