

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Department of Health and Human Services Division of Senior Services
Application for Older Americans Act, Title VI 2020-2023 Grant Funds)

RESOLUTION NO. 19-468

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham**
2 **Legislative Council with the power "[t]o consult, negotiate and conclude**
3 **agreements and contracts of behalf of the Tohono O'odham Nation with Federal,**
4 **State and local governments . . . on all matters within the authority of the Tohono**
5 **O'odham Council" and to "manage any funds within the exclusive control of the**
6 **Tohono O'odham Nation . . . and to appropriate these funds for the benefit of the**
7 **nation and its members" provided that "[a]ll expenditures of these funds shall be**
8 **pursuant to appropriations or budgets" authorized by resolution or ordinance**
9 **(Constitution, Article VI, Section 1(d)(2) and 1(f)); and**

10 **WHEREAS, the U.S. Department of Health and Human Services Administration for**
11 **Community Living has announced grant funding opportunity, "Funding for 2020-**
12 **2023 Older Americans Act Title VI Native American Programs" with an application**
13 **deadline of December 18, 2019; and**

14 **WHEREAS, Title VI of the Older Americans Act provides programs to support the**
15 **independence and well-being of tribal elders and caregivers living in their**
16 **communities with nutrition, supportive and caregiver services consistent with**
17 **locally-determined needs; and**

18 **WHEREAS, the Department of Health and Human Services Division of Senior Services has**
19 **prepared and submitted for review its application for Older Americans Act, Title**
20 **VI 2020-2023 grant funds for the continuation of elder services funding from the**
21 **Administration for Community Living/Administration on Aging Older Americans**
22 **Act Title VI Nutrition, Supportive Service and Caregiver Grants (Parts A/C), which**
23 **is incorporated by this reference; and**

24 **WHEREAS, the Health and Human Services Committee has been presented the grant**
25 **application and recommends its approval.**

26 **NOW, THEREFORE, BE IT RESOLVED that that Tohono O'odham Legislative Council approves the**
27 **Department of Health and Human Services Division of Senior Services**
28 **application for Older Americans Act, Title VI 2020-2023 grant funds (Parts A/C).**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH**
30 **day of DECEMBER, 2019 at a meeting at which a quorum was present with a vote of 2,961.9 FOR;**
31 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and 213.8[06] ABSENT, pursuant to the powers vested in the**
32 **Council by Article VI, Section 1(d)(2)and(f) of the Constitution of the Tohono O'odham Nation,**
33 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
34 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
35 **Act of June 18, 1934 (48 Stat.984).**




