

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Health and Human Services Healthy O'odham
Promotion Program Budget)

RESOLUTION NO. 19-469

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services ("DHHS") has prepared and**
8 **submitted for review and approval its FY 2021 Healthy O'odham Promotion**
9 **Program Budget, which is incorporated by this reference, in the amount of**
10 **\$2,241,130.00 to be funded from the Special Diabetes Program for Indians; and**

11 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
12 **reviewed the FY 2021 DHHS Healthy O'odham Promotion Program Budget and**
13 **recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2021 Department of Health and Human Services Healthy O'odham Promotion**
16 **Program Budget effective January 1, 2020 in the amount of \$2,241,130.00 to be**
17 **funded by the Special Diabetes Program for Indians.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
19 **Nation chairperson or any designated official is authorized to administer and**
20 **expend the FY 2021 Department of Health and Human Services Healthy O'odham**
21 **Promotion Program Budget, provided that any amendments or modifications**
22 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH**
24 **day of DECEMBER, 2019 at a meeting at which a quorum was present with a vote of 2,961.9 FOR;**
25 **-0- AGAINST; [01] NOT VOTING; and 213.8[06] ABSENT, pursuant to the powers vested in the**
26 **Council by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation,**
27 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
28 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
29 **Act of June 18, 1934 (48 Stat.984).**
