

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Office of Attorney General Budget Amendment No. 1)**

RESOLUTION NO. 19-471

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2020 Office of Attorney General Budget in the amount of \$2,656,958.37 was**
8 **approved by Resolution No. 19-380; and**

9 **WHEREAS, the Office of Attorney General has prepared and submitted for review and**
10 **approval its FY 2020 Office of Attorney General Budget Amendment No. 1, which is**
11 **incorporated by this reference and which will adjust operational and/or**
12 **personnel line items; and**

13 **WHEREAS, the FY 2020 Office of Attorney General Budget Amendment No. 1 will increase the**
14 **FY 2020 Office of Attorney General Budget by \$400,000.00 from \$2,656,958.37 to**
15 **\$3,056,958.37; and**

16 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
17 **2020 Office of Attorney General Budget Amendment No. 1 and recommend its**
18 **approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2020 Office of Attorney General Budget Amendment No. 1, which includes a**
21 **\$400,000.00 increase from \$2,656,958.37 to \$3,056,958.37 that shall be funded by**
22 **the Nation's general fund.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2020 Office of Attorney General Budget as amended, provided that**
26 **any amendments or modifications shall be submitted for prior approval by the**
27 **Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH**
29 **day of DECEMBER, 2019 at a meeting at which a quorum was present with a vote of 2,414.8 FOR;**
30 **547.1 AGAINST; -0-NOT VOTING; and 213.8 [07]ABSENT, pursuant to the powers vested in the**
31 **Council by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation,**
32 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
33 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
34 **Act of June 18, 1934 (48 Stat.984).**
