

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Appointment of Malcolm Lewis as Nation's Department of Public Safety  
Executive Director)**

**RESOLUTION NO. 20-015**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Nation's chairperson**  
2 **with authority to appoint the Nation's treasurer, and other officers and heads of**  
3 **all governmental departments with the approval of the Tohono O'odham**  
4 **Legislative Council (Constitution, Article VII, Section 2(e)); and**

5 **WHEREAS, the Nation's Chairman Ned Norris, Jr. has appointed Malcolm Lewis as the**  
6 **Nation's Department of Public Safety Executive Director, subject to the approval**  
7 **of the Legislative Council; and**

8 **WHEREAS, the Appointed Officers law, 1 T.O.C. Chapter 4, establishes the process for review**  
9 **of appointments by the appropriate oversight committee and the Council and the**  
10 **documents required, including copies of the current job description, the**  
11 **appointee's current resume, contact information, and current written**  
12 **background investigation report; and**

13 **WHEREAS, pursuant to Article III, Section 6(B) of the Legislative Rules of the Tohono**  
14 **O'odham Legislative Council, the chairperson's "appointee to the position of**  
15 **treasurer or other officers or heads of governmental departments shall not be**  
16 **added to any Legislative Council session agenda for approval unless the**  
17 **appropriate legislative committee interviews the appointee after receiving a**  
18 **resume and written background investigation report" containing detailed**  
19 **employment, education, credit, litigation, and other information necessary to**  
20 **determine the appointee's qualifications and fitness; and**

21 **WHEREAS, the Legislative Council Domestic Affairs Committee has received and reviewed**  
22 **the detailed written background investigation report and interviewed the**  
23 **appointee.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
25 **appointment of Malcolm Lewis as the Nation's Department of Public Safety**  
26 **Executive Director.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>**  
28 **day of JANUARY, 2020 at a meeting at which a quorum was present with a vote of 1,993.15 FOR;**  
29 **1,182.55 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the**  
30 **Council by Article VII, Section 2(e) of the Constitution of the Tohono O'odham Nation, adopted**  
31 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
32 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
33 **Act of June 18, 1934 (48 Stat.984).**


