

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Common Interest Confidentiality Agreement Between the United
States and the Tohono O'odham Nation)

RESOLUTION NO. 20-026

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "consult,**
2 **negotiate and conclude agreements and contracts on behalf of the Tohono**
3 **O'odham Nation with Federal, State and local governments..." (Constitution of the**
4 **Tohono O'odham Nation, Article VI, Section I(f)); and**

5 **WHEREAS, the Tohono O'odham Nation ("Nation") is currently in negotiations with the**
6 **United States to settle water rights claims for the Tohono O'odham Nation and**
7 **trust land; and**

8 **WHEREAS, during the course of negotiations all parties will inevitably need to share**
9 **information that is sensitive in nature; and**


10 **WHEREAS, the Nation has an interest in preventing disclosure of sensitive information; and**

11 **WHEREAS, the Tohono O'odham Nation Domestic Affairs and Water Resources Committees**
12 **have reviewed the Common Interest Confidentiality Agreement and recommend**
13 **that it be approved.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it approves**
15 **the Common Interest Confidentiality Agreement substantially in the form**
16 **attached hereto and authorizes the Chairperson of the Nation to execute it and**
17 **any related documents reasonably necessary to implement the Common Interest**
18 **Confidentiality Agreement.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**
20 **day of JANUARY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
22 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
25 **(48 Stat.984).**
