6		United States to settle water rights claims for the Tohono O'odham Nation and
7		trust land; and
8	WHEREAS,	during the course of negotiations all parties will inevitably need to share
9		information that is sensitive in nature; and
10	WHEREAS,	the Nation has an interest in preventing disclosure of sensitive information; and
11	WHEREAS,	the Tohono O'odham Nation Domestic Affairs and Water Resources Committees
12		have reviewed the Common Interest Confidentiality Agreement and recommend
13		that it be approved.
14	NOW, THER	EFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it approves
15		the Common Interest Confidentiality Agreement substantially in the form
16		attached hereto and authorizes the Chairperson of the Nation to execute it and
17		any related documents reasonably necessary to implement the Common Interest
18		Confidentiality Agreement.
