

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Resolution No. 19-347 "Approving FY 2020 Baboquivari District Budgets")**

**RESOLUTION NO. 20-056**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

11 ; and

12 **WHEREAS,** the FY 2020 Baboquivari District Budgets in the amount of \$5,804,638.14 was  
13 authorized by Baboquivari District Council Resolution No. 2019-B-66 and  
14 approved by Legislative Council Resolution No. 19-347; and

15 **WHEREAS,** the first resolved clause of Resolution No. 19-347 states:

16 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council  
17 approves the FY 2020 Baboquivari District Budgets in the amount of  
18 \$5,804,638.14, which shall be funded by the FY 2020 district gaming allocation in  
19 the amount of \$5,199,822.31 and the FY 2019 carry forward funding in the amount  
20 of \$604,755.83.

21 ; and

22 **WHEREAS,** the FY 2020 district gaming allocation amount in the resolved clause of  
23 Resolution No. 19-347 incorrectly states the amount as \$5,199,822.31 instead of  
24 the correct amount, \$5,199,882.31; and

25 **WHEREAS,** the Budget and Finance Committee has reviewed the proposed amendment to  
26 Resolution No. 19-347 to correct the FY 2020 district gaming allocation amount  
27 from \$5,199,822.31 to \$5,199,882.31 and recommends its approval.

28 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council amends the  
29 first resolved clause of Resolution No. 19-347 as follows:

30 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council  
31 approves the FY 2020 Baboquivari District Budgets in the amount of  
32 \$5,804,638.14, which shall be funded by the FY 2020 district gaming allocation in  
33 the amount of ~~\$5,199,822.31~~\$5,199,882.31 and the FY 2019 carry forward funding  
34 in the amount of \$604,755.83.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> day of FEBRUARY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
