

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 95-484, 115-82, 92-90, 2000-003, 01-094
and 04-109 to Reflect Legal Name Changes of Enrolled Members)**

RESOLUTION NO. 20-152

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws
2 and ordinances governing the enrollment and adoption of members (Article II,
3 Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono
4 O'odham Nation); and

5 **WHEREAS,** Articles VI and VII of the Nation's Enrollment Ordinance provide that the
6 Enrollment Committee is responsible for reviewing enrollment applications and
7 making recommendations to the Legislative Council regarding the eligibility of
8 applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and

9 **WHEREAS,** Article VIII of the Nation's Enrollment Ordinance provides that the Tohono
10 O'odham Legislative Council shall determine whether an application is approved
11 for membership and its determination, along with the resolution number and
12 date of enactment, shall be provided to the applicant; and


13 **WHEREAS,** the Enrollment Program has received the official documents showing the legal
14 name changes of enrolled members due to a variety of reasons, such as marriage,
15 divorce, or legal adoption; and

16 **WHEREAS,** the Enrollment Program therefore recommends that Resolution Nos. 95-484, 115-
17 82, 92-90, 2000-003, 01-094 and 04-109 be amended to reflect the amended names
18 for the members identified in the May 2020 Amended Enrollment Resolution
19 Summary, which is incorporated by this reference.

20 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution
21 Nos. 95-484, 115-82, 92-90, 2000-003, 01-094 and 04-109 are amended upon the
22 effective date of those resolutions to reflect the legal name changes for the
23 members identified in the May 2020 Amended Enrollment Resolution Summary.

24 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH
25 day of MAY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-
26 AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by
27 Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham
28 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; approved by the Acting
29 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
30 16 of the Act of June 18, 1934 (48 Stat.984).
