10	WHEREAS,	the Enrollment Program discovered that these same members were mistakenly
11	ļ	approved a second time for membership by Resolution No. 19-094; and
12	WHEREAS,	the Enrollment Program therefore recommends that Resolution No. 19-094 be
13		amended to delete the members identified in the attached Amending Enrollment
14		Resolution List for May 2020; and
15	WHEREAS,	the members that were originally approved in Resolution No. 10-401 will retain
16		the roll number and approval date identified in that resolution.
