

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Planning and Economic Development Department Credit and
Finance Program BIA P. L. 93-638 Budget Amendment No. 1)

RESOLUTION NO. 20-158

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d) (2); and**

7 **WHEREAS, the FY 2020 Planning and Economic Development Department Credit and**
8 **Finance Program BIA P.L. 93-638 Budget in the amount of \$297,815.39 was**
9 **approved by Resolution No. 19-300; and**

10 **WHEREAS, the Planning and Economic Development Department has prepared and**
11 **submitted for review and approval its FY 2020 Credit and Finance Program BIA**
12 **P.L. 93-638 Budget Amendment No. 1, which is incorporated by this reference and**
13 **which will adjust operational and/or personnel line items; and**

14 **WHEREAS, the FY 2020 Planning Department Credit and Finance Program BIA P.L. 93-638**
15 **Budget Amendment No. 1 will increase the FY 2020 BIA P.L. 93-638 Budget by**
16 **\$201,861.36 from \$297,815.39 to \$499,676.75; and**

17 **WHEREAS, the Commerce and Budget and Finance Committees have reviewed the FY 2020**
18 **Planning Department Credit and Finance Program BIA P.L. 93-638 Budget**
19 **Amendment No. 1 and recommend approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2020 Planning Department Credit and Finance Program BIA P.L. 93-638 Budget**
22 **Amendment No. 1 effective October 1, 2019, which includes a \$201,861.36 increase**
23 **from \$297,815.39 to \$499,676.75 that shall be funded by FY 2019 Credit and**
24 **Finance Program BIA P.L. 93-638 savings.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation chairperson or any designated official is authorized to administer and**
27 **expend the FY 2020 Planning and Economic Development Department Credit and**
28 **Finance Program BIA P.L. 93-638 Budget as amended, provided that any**
29 **amendments or modifications shall be submitted for prior approval by the**
30 **Tohono O'odham Legislative Council.**
