

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Gu-Vo District Gu-Vo Community Budget Amendment No. 1
and FY 2020 Kukatch Community Budget Amendment No. 1)

RESOLUTION NO. 20-159

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS,** the FY 2020 Gu-Vo District Budget in the amount of \$3,574,243.43 was authorized
13 **by Gu-Vo District Council Resolution No. GV-19-094 and approved by Legislative**
14 **Council Resolution No. 19-354, which was subsequently amended by Gu-Vo**
15 **District Council Resolution No. GV-20-016 and approved by Resolution No. 20-116**
16 **in the amount of \$3,853,547.32; and**

17 **WHEREAS,** by Gu-Vo District Council Resolution No. GV-20-025, the Gu-Vo District has
18 **authorized and submitted for review and approval its FY 2020 Gu-Vo Community**
19 **Budget Amendment No. 1 and FY 2020 Kukatch Community Budget Amendment**
20 **No. 1, which are incorporated by these references and which will adjust**
21 **operational and/or personnel line items; and**

22 **WHEREAS,** the FY 2020 Gu-Vo District Gu-Vo Community and Kukatch Community Budget
23 **Amendments No. 1 will not increase the FY 2020 Gu-Vo District Budget amount of**
24 **\$3,853,547.32; and**

25 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2020 Gu-Vo District Gu-
26 **Vo Community Budget Amendment No. 1 and FY 2020 Kukatch Community**
27 **Budget Amendment No. 1 and recommend its approval.**

28 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
29 **FY 2020 Gu-Vo District Gu-Vo Community Budget Amendment No. 1 in the amount**
30 **of \$357,424.34 and the FY 2020 Gu-Vo District Kukatch Community Budget**
31 **Amendment No. 1 in the amount of \$357,424.34, which do not change the FY 2020**
32 **Gu-Vo District Budget amount of \$3,853,547.32.**

3 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the**
4 **Nation's laws, provided that any amendments or modifications shall be**
5 **authorized under District Council resolution and submitted for prior approval by**
6 **the Tohono O'odham Legislative Council.**

7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH**
8 **day of MAY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
9 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
10 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
11 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
12 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
13 **(48 Stat.984).**


