1	WHEREAS,	the Tohono O'odham Legislative Council is further vested with the power to
2		"promote efforts which will preserve and protect the natural and cultural
3		environment of the Tohono O'odham Nation" and the responsibility to
4	:	"[p]reserve important historic, cultural and natural aspects of Tohono O'odham
5		national heritage, and maintain an environment which supports diversity"
6		(Constitution of the Tohono O'odham Nation, Article XVIII, Section 1 and Section
7		2(d)); and
8	WHEREAS,	the stated purpose of the International Sonoran Desert Alliance ("ISDA"), a non-
9		profit corporation founded in 1993, is "to design and implement projects that
10		promote education, environmental conservation, cultural preservation, and
11		sustainable economic development that protect the natural and diverse cultural
12		heritage of the Sonoran Desert." (ISDA Bylaws, Article II); and
13	WHEREAS,	the governing board of the ISDA is comprised of up to 20 elected or appointed
14		certified general members representing the indigenous and non-indigenous
15		resident citizens of the United States and Mexico, including an official
16		representative and alternate of the Nation who are appointed by the Legislative
17		Council (ISDA Bylaws, Article V, Section 5.1.1.); and
18	WHEREAS,	the Nation has historically appointed members of the Legislative Council
19		Cultural Preservation Committee to serve on the ISDA board until such time as
20		the Nation has appointed a successor or the appointee is no longer serving on the
21		Committee for any reason; and
22	WHEREAS,	by Resolution No. 14-016, the Legislative Council appointed Representative
23		Frances Miguel to serve as the Nation's representative and Representative
24		Frances Miguel no louger serves on the Legislative Council; and
25	WHEREAS,	the Cultural Preservation and Agricultural and Natural Resources Committees
26		recommend the appointment of Representative Marlakay Henry as the Nation's
27		representative and Representative Dallas Lewis as alternate to the ISDA board of
28		directors.
29	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council appoints
30		Representative Marlakay Henry as the Nation's representative and
31		Representative Dallas Lewis as alternate to the ISDA board of directors.
