10	WHEREAS,	the chief judge has submitted Amy Courson's resume, letter of interest, and a						
11		letter of recommendation for her appointment as a pro tempore judge to the						
12		Tohono O'odham Judicial Court; and						
13	WHEREAS,	the Judiciary Committee, having legislative oversight of matters pertaining to the						
14		Tohono O'odham Judicial Court, reviewed Amy Courson's resume, letter of						
15		interest, and the chief judge's letter of recommendation, and recommends						
16		appointment.

18		Amy Courson to the Tohono O'odham Judicial Court as a pro tempore judge for a
