3		ordinances governing the enrollment and adoption of members and the
4		relinquishment and loss of membership"; and
5	WHEREAS,	in accordance with the Tohono O'odham Nation's Enrollment Ordinance,
6		Ordinance No. 05-81 as amended the Enrollment Committee has received a
7		written statement from 01 tribal member who has expressed their intent to
8	į	relinquish their membership with the Tohono O'odham Nation and the members
9		are identified in the June 2020 Relinquishment List, which is incorporated by this
10		reference; and
11	WHEREAS,	pursuant to Article IX Section 1 of the Enrollment Ordinance,
12		A member of the Nation may relinquish his membership in the
13		Nation by submitting a written statement clearly expressing an
14		intent to relinquish his membership to the Council, a copy of
15		which must be served on the committee. The written statement
16		must be signed by the person wishing to relinquish his membership
17		or, if a minor or incompetent, by the parent(s), guardian or other
18		person legally authorized to act on his behalf. Relinquishment
19		does not require the approval of the Council, but is effective upon
20		receipt of the statement by the Council and cannot be subsequently
21		denied. Upon recognition by the Council that the individual has
22		renounced his membership, his name shall be deleted from the
23		membership roll.
24	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
25		recognizes that the one individual identification that

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby recognizes that the one individual identified in the June 2020 Relinquishment List have relinquished their membership in the Tohono O'odham Nation and orders the removal of their names from the Nation's membership roll.

 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH day of JUNE, 2020 at a meeting at which a quorum was present with a vote of 2,384.1 FOR; -0-AGAINST; [01] NOT VOTING; and -0-ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary-Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
