

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2020 Hewel Ni'ok KOHN Corporation for Public Broadcasting  
Community Service Grant Restricted Budget Amendment No. 1)**

**RESOLUTION NO. 20-181**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** by Resolution No. 19-318 the Legislative Council approved the FY 2020 Hewel Ni'ok  
8 KOHN Corporation for Public Broadcasting ("CPB") Community Service Grant  
9 ("CSG") Restricted Budget in the amount of \$90,554.70; and

10 **WHEREAS,** Hewel Ni'ok has prepared and submitted for review and approval its FY 2020  
11 Hewel Ni'ok KOHN CPB CSG Restricted Budget Amendment No. 1, which is  
12 incorporated by this reference and which will adjust operational and/or  
13 personnel line items; and

14 **WHEREAS,** the FY 2020 Hewel Ni'ok KOHN CPB CSG Restricted Budget Amendment No. 1 will  
15 increase the FY 2020 Hewel Ni'ok KOHN CPB CSG Restricted Budget by \$8,505.87  
16 from \$90,554.70 to \$99,060.57; and

17 **WHEREAS,** the Cultural Preservation and Budget and Finance Committees have reviewed the  
18 FY 2020 Hewel Ni'ok KOHN CPB CSG Restricted Budget Amendment No. 1 and  
19 recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
21 FY 2020 Hewel Ni'ok KOHN CPB CSG Restricted Budget Amendment No. 1, effective  
22 October 1, 2019, which includes a \$8,505.87 increase from \$90,554.70 to  
23 \$99,060.57 that shall be funded by the FY 2020 final allocation and FY 2019 carry  
24 forward funds.

25 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
26 Nation chairperson or any designated official is authorized to administer and  
27 expend the FY 2020 Hewel Ni'ok KOHN CPB CSG Restricted Budget as amended,  
28 provided that any amendments or modifications shall be submitted for prior  
29 approval by the Tohono O'odham Legislative Council.

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup>**  
31 **day of JUNE, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**  
32 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**  
33 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
36 **18, 1934 (48 Stat.984).**
