The management of these funds shall be only by a 6 treasurer or other authorized officer of the district council who has furnished 7 a surety bond satisfactory to the treasurer of the Tohono O'odham Nation, and 8 all expenditures of these funds shall be by checks signed by such treasurer or 9 other authorized officer and the chairman or vice chairman of the district 10 council. 11 ; and 12 WHEREAS. the FY 2020 San Lucy District Budget in the amount of \$11,864,798.39 was 13 authorized by San Lucy District Resolution No. SL 08-205-19 and approved by 14 Legislative Council Resolution No. 19-357 and subsequently amended by 15 Legislative Council Resolution No. 20-007 and Legislative Council Resolution No. 16 20-160 in the amount of \$12,785,013.88; and 17 WHEREAS. by San Lucy District Resolution No. SL 05-90-20, the San Lucy District has prepared 18 and submitted for review and approval its FY 2020 San Lucy District Council 19 Budget Amendment No. 3 which is incorporated by this reference and which will 20 adjust operational and/or personnel line items; and 21 WHEREAS, the FY 2020 San Lucy District Council Budget Amendment No. 3 will not change the 22 total FY 2020 San Lucy District Budget amount of \$12,785,013.88; and 23 the Budget and Finance Committee has reviewed the FY 2020 San Lucy District WHEREAS, 24 Council Budget Amendment No. 3 and recommends its approval. 25 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 26 FY 2020 San Lucy District Council Budget Amendment No. 3, which will not change 27 the total FY 2020 San Lucy District Budget amount of \$12,785,013.88. 28 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2020 San Lucy 29 District Budget as amended shall be managed and expended in accordance with 30 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the 31 Nation's laws, provided that any amendments or modifications shall be 32 authorized under District Council resolution and submitted for prior approval by 33 the Tohono O'odham Legislative Council.
