13		of \$3,117,497.01 was authorized by Pisinemo District Council Resolution No. 19-
14		P-35 and approved by Legislative Council Resolution No. 19-349; and
15	WHEREAS,	by Pisinemo District Council Resolution No. 20-P-21, the Pisinemo District has
16		prepared and submitted for review and approval its FY 2020 Pisinemo District
17		Operations Budget Amendment No. 1, which is incorporated by this reference and
18		which will adjust operational and/or personnel line items; and
19	WHEREAS,	the FY 2020 Pisinemo District Operations Budget Amendment No.1 will not
20		change the original budget amount of \$3,117,497.01; and
21	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2020 Pisinemo District
22		Operations Budget Amendment No. 1 and recommends its approval.
23	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
24		FY 2020 Pisinemo District Operations Budget Amendment No. 1, which will not
25		change the original budget amount of \$3,117,497.01.

30		shall be authorized under District Council resolution and submitted for prior
31		approval by the Tohono O'odham Legislative Council.
