

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Pisinemo District Operations Budget Amendment No. 1)**

RESOLUTION NO. 20-184

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS, the FY 2020 Pisinemo District Operations and Community Budgets in the amount**
13 **of \$3,117,497.01 was authorized by Pisinemo District Council Resolution No. 19-**
14 **P-35 and approved by Legislative Council Resolution No. 19-349; and**

15 **WHEREAS, by Pisinemo District Council Resolution No. 20-P-21, the Pisinemo District has**
16 **prepared and submitted for review and approval its FY 2020 Pisinemo District**
17 **Operations Budget Amendment No. 1, which is incorporated by this reference and**
18 **which will adjust operational and/or personnel line items; and**

19 **WHEREAS, the FY 2020 Pisinemo District Operations Budget Amendment No.1 will not**
20 **change the original budget amount of \$3,117,497.01; and**

21 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2020 Pisinemo District**
22 **Operations Budget Amendment No. 1 and recommends its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
24 **FY 2020 Pisinemo District Operations Budget Amendment No. 1, which will not**
25 **change the original budget amount of \$3,117,497.01.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2020 Pisinemo**
27 **District Operations Budget as amended shall be managed and expended in**
28 **accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham**
29 **Nation and the Nation's laws, provided that any amendments or modifications**
30 **shall be authorized under District Council resolution and submitted for prior**
31 **approval by the Tohono O'odham Legislative Council.**


