

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Executive Branch COVID-19 Outbreak Budget Amendment No. 1)

RESOLUTION NO. 20-186

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2020 Executive Branch COVID-19 Outbreak Budget in the amount of
8 \$3,500,000.00 was approved by Resolution No. 20-094; and

9 **WHEREAS,** the Executive Branch has prepared and submitted for review and approval its FY
10 2020 COVID-19 Outbreak Budget Amendment No. 1, which is incorporated by this
11 reference and which will adjust operational and/or personnel line items; and

12 **WHEREAS,** the FY 2020 Executive Branch COVID-19 Outbreak Budget Amendment No. 1 will
13 increase the total budget by \$832,580.00 from \$3,500,000.00 to \$4,332,580.00,
14 which will be funded by the Nation's general fund surplus; and

15 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2020 Executive Branch
16 COVID-19 Outbreak Budget Amendment No. 1 and recommend its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 FY 2020 Executive Branch COVID-19 Outbreak Budget Amendment No. 1, which
19 will increase the total budget by \$832,580.00 from \$3,500,000.00 to \$4,332,580.00
20 that shall be funded by the Nation's general fund surplus.

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
22 Nation chairperson or any designated official is authorized to administer and
23 expend the FY 2020 Executive Branch COVID-19 Outbreak Budget as amended,
24 provided that any amendments or modifications shall be submitted for further
25 prior approval by the Tohono O'odham Legislative Council.

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH**
27 **day of JUNE, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat.984).**
