**RESOLUTION NO. 20-192** 

1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2		the power to enact laws "to promote, protect and provide for public health, peace,
3		morals education and general welfare of the Tohono O'odham Nation and its
4		members" (Constitution, Article VI, Section 1(C)(2)); and
5	WHEREAS,	the Tohono O'odham Ki:Ki Association ("TOKA") is the Nation's tribally
6		designated housing entity in accordance with the Native American Housing
7	1	Assistance and Self-Determination Act of 1996, 25 U.S.C §4101, et seq., P.L. 104-
8		330, 110 Stat. 4016 ("NAHASDA"); and
9	WHEREAS,	to qualify for funds from the Indian Housing Block Grant Program Cares Funding,
10		the NAHASDA requires submission of an annual Indian Housing Plan ("IHP") by
11	•	the Indian tribe or by the tribe's designated housing entity (25 U.S.C §4112); and
12	WHEREAS,	pursuant to Article IX of the Nation's TOKA Ordinance, 18 Tohono O'odham Code,
13		Chapter 1, the TOKA shall submit annually to the United States Department of
14		Housing and Urban Development's Southwest Area Office of Native American
15		Programs ("SWONAP") the Nation's Indian Housing Plan after review and
16		approval by Legislative Council resolution (TOKA Ordinance, Article IX, 1.,
17		http://tolc-nsn.org/docs/Title18Ch1.pdf); and
18	WHEREAS,	under the direction of the TOKA's executive director, the TOKA prepared and
19		submitted the Nation's 2020 Indian Housing Plan for the IHBG Cares Funding to
20		TOKA's Board of Directors for review and approval (TOKA Ordinance, Article IX, 1,
21		b., ii.); and
22	WHEREAS,	after approving the Nation's 2020 Indian Housing Plan for IHBG Cares Funding by
23		Resolution No. 06-01-20, the TOKA's Board of Directors provided the IHP for IHBG
24		Cares funding to the Legislative Housing Committee for review and approval
25		(TOKA Ordinance, Article IX, 1, b., iii.); and
26	WHEREAS,	in accordance with federal regulations promulgated in accordance with the
27		CARES Act, the TOKA began expending CARES Funding; and
28	WHEREAS,	the Legislative Housing Committee recommends approval of the Nation's 2020
29		Indian Housing Plan for the IHBG Cares Funding.
30	NOW, THERE	FORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it ratifies
31		approval of the Nation's 2020 Indian Housing Plan for IHBG Cares Funding;
32		provided that any amendments are subject to Legislative Council review and
33		approval.
