9		with Federal, State and local governments and other Indian tribes or their
10		departments, agencies, or political subdivisions" (Constitution of the Tohono
11		O'odham Nation Article VI, Section 1(f)); and
12	WHEREAS,	the Arizona Department of Economic Security for Workforce Innovation and
13		Opportunity Act ("WIOA") Title 1B Intergovernmental Agreement ("IGA") was
14		approved by Resolution No. 18-485; and
15	WHEREAS,	the Arizona Department of Economic Security has granted the Tohono O'odham
16		Nation One Stop Division \$620,269.00 for a period beginning on July 1, 2019
17		through June 30, 2021 as detailed in Amendment No. 1 to the IGA; and
18	WHEREAS,	the Human Resources Development Committee has reviewed the Arizona
19		Department of Economic Security IGA Amendment No. 1 and recommends its
20		approval.
21	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
22		Arizona Department of Economic Security Intergovernmental Agreement
23		Amendment No. 1 effective July 1, 2019.
24	BE IT FINALL	Y RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
25		Nation chairperson or any designated official is authorized to administer and
26		execute the Intergovernmental Agreement, provided that any amendments shall
27		be submitted for prior approval by the Tohono O'odham Legislative Council.
