12	WHEREAS,	Chairman Ned Norris, Jr. has nominated Sheila Espino for appointment as a
13	1	member of the Tohono O'odham Nation Health Care Governing Body, subject to
14		Legislative Council confirmation; and
15	WHEREAS,	Sheila Espino is an enrolled Nation's member and possesses sufficient education,
16		skills, and experience in health care; and
17	WHEREAS,	the Health and Human Services and Rules Committees have reviewed the
18		nomination and recommend confirmation.
