

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Confirming the Nomination of Sheila Espino for Appointment as a Member of
the Tohono O'odham Nation Health Care Governing Body)

RESOLUTION NO. 20-205

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2 the power to "provide for, appoint, or provide for the appointment of, and
3 prescribe the duties and powers of committees, boards, officers and agents" and
4 "to promote, protect and provide for public health, peace, morals, education and
5 general welfare of the Tohono O'odham Nation and its members" (Constitution,
6 Article VI, Section 1(b) and Section 1(c)(2)); and

7 **WHEREAS,** by Resolution No. 19-087, the Legislative Council approved the March 2019
8 Amendments to the Tohono O'odham Nation Health Care Governing Body Bylaws,
9 which established a Governing Body comprised of seven members of which five
10 members are voting members nominated by the Nation's chairperson and
11 confirmed by the Legislative Council to serve staggered four-year terms; and

12 **WHEREAS,** Chairman Ned Norris, Jr. has nominated Sheila Espino for appointment as a
13 member of the Tohono O'odham Nation Health Care Governing Body, subject to
14 Legislative Council confirmation; and

15 **WHEREAS,** Sheila Espino is an enrolled Nation's member and possesses sufficient education,
16 skills, and experience in health care; and

17 **WHEREAS,** the Health and Human Services and Rules Committees have reviewed the
18 nomination and recommend confirmation.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council confirms the
20 nomination of Sheila Espino as a member of the Tohono O'odham Nation Health
21 Care Governing Body to replace an interim Governing Body member for a term to
22 expire June 30, 2024.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH
24 day of JUNE, 2020 at a meeting at which a quorum was present with a vote of 2,936.8 FOR; -0-
25 AGAINST; -0- NOT VOTING; and 238.9 [02] ABSENT, pursuant to the powers vested in the Council
26 by Article VI, Section 1(b), Section 1(d), and Section 1(c)(2) of the Constitution of the Tohono
27 O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by
28 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
29 to Section 16 of the Act of June 18, 1934 (48 Stat.984).
