

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Economic Development Proposal)**

RESOLUTION NO. 20-206

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power "to promote, protect and provide for . . . general welfare of the Tohono**
3 **O'odham Nation and its members" (Constitution, Article VI, Section 1(c)(2)); and**
4 **WHEREAS, the Legislative Council has by Resolution No. 19-465 approved an agreement, as**
5 **amended by Resolution No. 20-102 and Resolution No. 20-173 to benefit the**
6 **Nation and its members; and**
7 **WHEREAS, on June 18, 2020, the Legislative Council was presented with an economic**
8 **development proposal (the "Economic Development Proposal") that would**
9 **provide additional resources to serve the Nation's members; and**
10 **WHEREAS, the Commerce, Budget and Finance, and Agricultural and Natural Resource**
11 **Committees have reviewed the Economic Development Proposal and**
12 **recommend it be approved.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
14 **Economic Development Proposal in the form presented to the Legislative Council**
15 **in closed session on June 18, 2020, provided that the Economic Development**
16 **Proposal shall remain confidential and shall not be reported or disclosed.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH**
18 **day of JUNE, 2020 at a meeting at which a quorum was present with a vote of 3,057.97 FOR; 117.8**
19 **AGAINST; [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
20 **Article VI, Section 1(c)(2) Section 1(d) and Section 1(i) of the Constitution of the Tohono O'odham**
21 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
22 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
23 **16 of the Act of June 18, 1934 (48 Stat.984).**
