8		development proposal (the "Economic Development Proposal") that would
9		provide additional resources to serve the Nation's members; and
10	WHEREAS,	the Commerce, Budget and Finance, and Agricultural and Natural Resource
11		Committees have reviewed the Economic Development Proposal and
12		recommend it be approved.
13	NOW. THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
14		Economic Development Proposal in the form presented to the Legislative Council
		in closed session on June 18, 2020, provided that the Economic Development
