**RESOLUTION NO. 20-207** 

1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2		the authority to "consult, negotiate and conclude agreements and contracts on
3		behalf of the Tohono O'odham Nation with Federal, State and local governments"
4		and to "promote, protect and provide for public health, peace, morals, education
5		and general welfare of the Tohono O'odham Nation and its members"
6		(Constitution, Article VI, Section 1(f) and Section 1(c)(2)); and
7	WHEREAS,	Gabriella Cázares-Kelly, a member of the Tohono O'odham Nation is running for
8		the position of Pima County Recorder and requesting support from the Tohono
9		O'odham Nation; and
10	WHEREAS,	Gabriella Cázares-Kelly, as a co-founder of Indivisible Tohono, a grassroots
11		organization has advocated for numerous tribal issues and actively engaged in
12		local politics serving as the President of the Progressive Democrats of Southern
13		Arizona and as the Vice-President of the Arizona Democratic Party's Native
14		American Caucus; and
15	WHEREAS,	the Appropriations Committee met with Gabriella Cázares-Kelly, discussed the
16		Nation's issues, and recommends endorsing her for the position of Pima County
17		Recorder, provided that the Legislative Council encourages Nation's members to
18		vote as they deem appropriate.
19	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council endorses
20		Gabriella Cázares-Kelly for the position of Pima County Recorder, provided that
21		Nation's members are encouraged to vote as they deem appropriate.
