

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting U.S. Department of Health and Human Services, Administration for
Community Living, Native American Programs Title VI Coronavirus Aid, Relief,
and Economic Security Act Grant and Approving FY 2021 Department of
Health and Human Services Title VI CARES Act Budget)**

RESOLUTION NO. 20-217

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Tohono O'odham
2 Legislative Council with the power "[t]o consult, negotiate and conclude
3 agreements and contracts on behalf of the Tohono O'odham Nation with Federal,
4 State and local governments" and "to manage any funds within the exclusive
5 control of the Tohono O'odham Nation . . . and to appropriate these funds for the
6 benefit of the nation and its members" provided that "[a]ll expenditures of these
7 funds shall be pursuant to appropriations or budgets" authorized by resolution
8 or ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section
9 1(d)(2) and (f)); and

10 **WHEREAS,** the Department of Health and Human Services received a grant award from the
11 U.S. Department of Health and Human Services for Title VI Coronavirus Aid,
12 Relief, and Economic Security ("CARES") Act grant in the amount of \$116,750.00
13 for the period of April 1, 2020 to September 30, 2021 for supportive services for
14 coronavirus response efforts; and

15 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
16 review and approval its FY 2021 Title VI CARES Act Budget, which is incorporated
17 by this reference, in the amount of \$116,750.00 to be funded by the Nation's
18 general fund pending reimbursement from the U.S. Department of Health and
19 Human Services; and

20 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
21 reviewed the FY 2021 Department of Health and Human Services Title VI CARES
22 Act Budget and recommend its approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council accepts the
24 U.S. Department of Health and Human Services Title VI Coronavirus Aid, Relief,
25 and Economic Security Act grant in the amount of \$116,750.00 and approves the
26 FY 2021 Department of Health and Human Services Title VI CARES Act Budget,
27 effective April 1, 2020 to September 30, 2021, in the amount of \$116,750.00 that
28 shall be funded by the Nation's general fund pending reimbursement from the
29 U.S. Department of Health and Human Services for the continuation of this grant.

30 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
31 Nation chairperson or any designated official is authorized to administer and
32 expend the FY 2021 Department of Health and Human Services Title VI CARES Act



Budget, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.


The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH day of JULY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) and 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
