LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(Setting July 27, 2020 Special Session to Address District Allocations Under the Gaming Revenue Distribution Formula and District Allocation Guidelines)

LEGISLATIVE ORDER NO. 20-224

WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to regulate all meetings of the Tohono O'odham Council, standing committees, boards and special committees." (Constitution of the Tohono O'odham Nation, Article VI, Section 1(a)); and the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with the authority to "by majority vote, call for a special session" (Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and the Budget and Finance Committee has requested a special session on July 27, 2020 to address District Allocations under the Gaming Revenue Distribution Formula and District Allocation Guidelines.

NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a special session on July 27, 2020 to address District Allocations under the Gaming Revenue Distribution Formula and District Allocation Guidelines.

The foregoing Order was passed by the Tohono O'odham Legislative Council on the 16TH day of JULY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-AGAINST; -0-NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
