

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget)**

**RESOLUTION NO. 20-226**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS the Tohono O'odham Nation ("Nation") received \$61,115,398.00 from the United**  
8 **States Coronavirus Relief Fund ("Relief Fund") as approved by the Coronavirus**  
9 **Aid, Relief, and Economic Security Act ("CARES Act"); and**

10 **WHEREAS, the Executive Branch has prepared and submitted for review and approval the FY**  
11 **2021 Tohono O'odham Nation Coronavirus Relief Fund Budget for the period**  
12 **from March 1, 2020 to December 30, 2020, which is incorporated by this reference,**  
13 **in the amount of \$61,115,398.00 to be funded by the CARES Act Coronavirus Relief**  
14 **Fund; and**

15 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2021 Tohono O'odham**  
16 **Nation Coronavirus Relief Fund Budget and recommends its approval.**


17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
18 **FY 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget effective March**  
19 **1, 2020 through December 30, 2020 in the amount of \$61,115,398.00, which shall**  
20 **be funded by the CARES Act Coronavirus Relief Fund.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
22 **Nation chairperson or any designated official is authorized to administer and**  
23 **expend the FY 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget,**  
24 **provided that any amendments or modifications shall be submitted for prior**  
25 **approval by the Tohono O'odham Legislative Council.**


26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>**  
27 **day of JULY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat.984).**
