10		O'odham Legislative Council shall determine whether an application is approved
11		for membership and its determination, along with the resolution number and
12	i	date of enactment, shall be provided to the applicant; and
13	WHEREAS,	the Enrollment Program has received the official documents showing the legal
14		name changes of enrolled members due to a variety of reasons, such as marriage,
15		divorce, or legal adoption; and
16	WHEREAS,	the Enrollment Program therefore recommends that Resolution Nos. 15-80, 06-
17		84, 292-90, and 07-657 be amended to reflect the amended names for the
18		members identified in the August 2020 Amended Enrollment Resolution
19		Summary, which is incorporated by this reference.
