

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving and Accepting Amendment No. 1 to the Intergovernmental Agreement**  
**between the Tohono O'odham Nation and the Arizona Department of Economic**  
**Security for the Planned Social Services Title XX Block Grant)**

**RESOLUTION NO. 20-236**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham**  
2 **Legislative Council with the power “[t]o consult, negotiate, and conclude**  
3 **agreements and contracts on behalf of the Tohono O'odham Nation with Federal,**  
4 **State, and local governments and other Indian tribes or their departments,**  
5 **agencies, or political subdivisions, or with private persons or organizations on all**  
6 **matters within the authority of the Tohono O'odham Council.” (Constitution,**  
7 **Article VI, Section 1(f)); and**

8 **WHEREAS, the Intergovernmental Agreement between the Tohono O'odham Nation**  
9 **(“Nation”) and the Arizona Department of Economic Security (“ADES”) for the**  
10 **Planned Social Services Title XX Block Grant, ADES Contract number DI 20002237,**  
11 **was approved by Resolution No. 19-250 for the period of July 1, 2019 through June**  
12 **30, 2024 in the amount of \$103,012.00 per year; and**

13 **WHEREAS, the Department of Education has submitted for review and approval Amendment**  
14 **No. 1 to the Intergovernmental Agreement, which is incorporated by this**  
15 **reference, for the period of July 1, 2020 through June 30, 2021 in the amount of**  
16 **\$103,012.00, the amount of the contract reimbursement ceiling; and**

17 **WHEREAS, the Human Resources Development Committee has reviewed Amendment No. 1**  
18 **to the Intergovernmental Agreement between the Nation and ADES for the**  
19 **Planned Social Services Title XX Block Grant and recommends its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**  
21 **accepts Amendment No. 1 to the Intergovernmental Agreement between the**  
22 **Tohono O'odham Nation and the Arizona Department of Economic Security for**  
23 **the Planned Social Services Title XX Block Grant in substantially the form**  
24 **attached.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
26 **Nation chairperson or any designated official is authorized to execute**  
27 **Amendment No. 1 to the Intergovernmental Agreement, provided that any**  
28 **amendments shall be submitted for prior approval by the Tohono O'odham**  
29 **Legislative Council.**


