1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2		the power "to consult, negotiate and conclude agreements and contracts on
3		behalf of the Tohono O'odham Nation with Federal, State and local governments
4		and other Indian tribes or departments, agencies, or political subdivisions, or
5		with private persons or organizations on all matters within the authority of the
6		Tohono O'odham Council" (Constitution, Article VI, Section 1(f)); and
7	WHEREAS,	the Arizona Department of Health Services, through the Bureau of Public Health
8	1	Emergency Preparedness, has worked with Arizona tribes to improve the
9		preparedness of each community in the event of any public health emergency,
10		with most projects funded by grants from the U.S. Department of Health and
11		Human Services Centers for Disease Control; and
12	WHEREAS,	the Tohono O'odham Nation ("Nation") has negotiated an Intergovernmental
13 14		Agreement with the Arizona Department of Health Services, No. ADHS2020-007,
15		for Public Health Emergency Preparedness Program, which is incorporated by
16	***************************************	this reference, for a period of five years from July 1, 2020 to June 30, 2025; and
17	WHEREAS,	while the Intergovernmental Agreement ("IGA") does not expressly require a
18		waiver of the Nation's sovereign immunity, the IGA includes a mutual
19		indemnification clause, arbitration clause, and the IGA is subject to the laws of
20		Arizona; and
21	WHEREAS,	the Intergovernmental Agreement stipulates a 10% match requirement, which
22		will be met through cost share of the Department of Health and Human Services
23		Division of Community Health Services Public Health Preparedness Coordinator
24	TAULED DAG	salary; and
25	WHEREAS,	the Health and Human Services Committee has reviewed the Intergovernmental
26		Agreement between the Nation and the Arizona Department of Health Services
27	NIGHTAL MARKET NA	and recommend its approval.
28	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:
29		1. Approves the Intergovernmental Agreement, No. ADHS2020-007, between
30		the Nation and the Arizona Department of Health Services for Public
31		Health Emergency Preparedness Program as a fixed price contract for a
32		period of five years from July 1, 2020 to June 30, 2025; provided that
33		nothing in the Intergovernmental Agreement or this resolution shall be
		construed as a waiver of the Nation's sovereign immunity.
