10		Adult Members for review and approval for the 2020 Non-Gaming Per Capita
11		Distribution for administration of the 2020 Non-Gaming Per Capita Distribution;

13	WHEREAS,	according to the Master List for the 2020 Non-Gaming Per Capita Distribution for
14		Eligible Tohono O'odham Adult Members, the total number of eligible Tohono
15		O'odham Adult Members for the 2020 Non-Gaming Per Capita is 24,947 members;

17	WHEREAS,	Rules Committee has reviewed the Master List for the 2020 Non-Gaming Per
18		Capita Distribution for Eligible Tohono O'odham Adult Members and
19		recommends its approval.
20	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
21		Master List for the 2020 Non-Gaming Per Capita Distribution for Adult Tohono
22		O'odham Members for use by Membership Services in the administration of the
23		2020 Non-Gaming Per Capita Plan; provided that:
24		(1) Disbursement of the 2020 Non-Gaming Per Capita payment to each
25		eligible adult Tohono O'odham member is contingent upon certification
26		of member's eligibility in accordance with Section III.D(1) of the Non-
27		Gaming Per Capita Plan.
28		(2) Approval of the Master List shall not constitute the enrollment of any
29		person that is not otherwise duly enrolled in accordance with the
30		Constitution and laws of the Tohono O'odham Nations.
31		(3) The Master list may be corrected by resolution of the Tohono O'odham
32		Legislative Council.
