13	WHEREAS,	by Resolution No. 17-552, the Tohono O'odham Nation approved Amendment No.
14		1 to the Tohono O'odham Nation Per Capita Trust; and
15	WHEREAS,	pursuant to Tohono O'odham Legislative Council Resolution No. 20-070, the
16		Nation adopted the 2020 Tohono O'odham Nation Non-Gaming Per Capita Plan;

18	WHEREAS,	the 2020 Tohono O'odham Nation Non-Gaming Per Capita Plan identifies non-
19		gaming funds to be distributed to eligible, minor members to receive a non-
20		gaming per capita payment when they turn 18 years old; and
21	WHEREAS,	it is necessary to amend the Tohono O'odham Nation Per Capita Trust to allow
22		non-gaming funds to be contributed to the Trust; and
23	WHEREAS,	Amendment No. 2 to the Tohono O'odham Nation Per Capita Trust, which is
24		incorporated by this reference, proposes amendments to allow for non-gaming
25		funds to be contributed to the Trust; and
26	WHEREAS,	the Investment Committee has reviewed Amendment No. 2 to the Tohono
27		O'odham Nation Per Capita Trust and recommends approval.
