11	WHEREAS,	the Judiciary and Budget and Finance Committee has reviewed the FY 2021
12		Tohono O'odham Nation Judicial Branch Budget and recommend its approval.
13	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
14		FY 2021 Tohono O'odham Nation Judicial Branch Budget effective October 1, 2020
15		in the amount of \$7,430,265.86, which shall be funded by the Nation's general
16		fund.
