

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Legislative Branch Budget)

RESOLUTION NO. 20-251

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Legislative Branch has prepared and submitted for review and approval its**
8 **FY2021 Legislative Branch Budget, which is incorporated by this reference, in the**
9 **amount of \$4,917,618.00 to be funded from the Nation's general fund; and**


10 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2021 Legislative Branch**
11 **Budget and recommends its approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
13 **FY 2021 Legislative Branch Budget effective October 1, 2020 in the amount of**
14 **\$4,917,618.00 which shall be funded by the Nation's general fund.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
16 **Legislative Council chairperson or any designated official is authorized to**
17 **administer and expend the FY 2021 Legislative Branch Budget, provided that any**
18 **modifications shall be submitted to the Budget and Finance Committee for**
19 **approval on behalf of the Legislative Council and amendments shall be submitted**
20 **for prior approval by the Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
22 **day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 2,628.6 FOR;**
23 **~~0~~ AGAINST; 547.1 [01] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the**
24 **Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,**
25 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
26 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
27 **Act of June 18, 1934 (48 Stat.984).**
