

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2021 Planning Department Realty Program Land Acquisition Budget)**

**RESOLUTION NO. 20-257**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Planning Department has prepared and submitted for review and approval**  
8 **its FY 2021 Realty Program Land Acquisition Budget, which is incorporated by this**  
9 **reference in the amount of \$330,000.00 to be funded from the Nation's Land**  
10 **Acquisition fund; and**


11 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**  
12 **have reviewed the FY 2021 Planning Department Realty Program Land**  
13 **Acquisition Budget and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
15 **FY 2021 Planning Department Realty Program Land Acquisition Budget effective**  
16 **October 1, 2020 in the amount of 330,000.00, which shall be funded by the Nation's**  
17 **Land Acquisition fund.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
19 **Nation chairperson or any designated official is authorized to administer and**  
20 **expend the FY 2021 Planning Department Realty Program Land Acquisition**  
21 **Budget, provided that any amendments or modifications shall be submitted for**  
22 **prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>**  
24 **day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**  
25 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
26 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
27 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
29 **18, 1934 (48 Stat.984).**
