7	WHEREAS,	the Department of Education has prepared and submitted for review and
8		approval its FY 2021 Child Care and Development Fund Discretionary Budget,
9		which is incorporated by this reference, in the amount of \$2,924,425.00 and its FY
10		2021 Child Care and Development Fund Mandatory Budget, which is
11		incorporated by this reference, in the amount of \$590,451.00, for a combined total
12		amount of \$3,514,876.00 to be funded by the Nation's general fund pending
13		reimbursement from the grantor, the United States Department of Health and
14		Human Services; and
15	WHEREAS,	the Human Resources Development and Budget and Finance Committees have
16		reviewed the FY 2021 Department of Education Child Care and Development Fund
17		Discretionary Budget and the FY 2021 Department of Education Child Care and
18		Development Fund Mandatory Budget and recommend their approval.
19	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
20		FY 2021 Department of Education Child Care and Development Fund
21		Discretionary Budget and the FY 2021 Department of Education Child Care and
22		Development Fund Mandatory Budget effective October 1, 2020 in the amount of
23		\$3,514,876.00, which shall be funded by the Nation's general fund pending
24		reimbursement from the grantor, the United States Department of Health and
25		Human Services.
26	BE IT FINALL	Y RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
27		Nation chairperson or any designated official is authorized to administer and
28		expend the FY 2021 Department of Education Child Care and Development Fund
29		Discretionary Budget and the FY 2021 Department of Education Child Care and
30		Development Fund Mandatory Budget, provided that any amendments or
31		modifications shall be submitted for prior approval by the Tohono O'odham
32		Legislative Council.
