

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Education Division of Early Childhood
Development Head Start Budgets)

RESOLUTION NO. 20-259

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Education has prepared and submitted for review and**
8 **approval its FY 2021 Division of Early Childhood Development Head Start**
9 **Program Grant Budget in the amount of \$1,517,964.37; its FY 2021 Division of**
10 **Early Childhood Development Head Start Program Training and Technical**
11 **Budget in the amount of \$23,205.00; and its FY 2021 Division of Early Childhood**
12 **Development Head Start Program Grant Administration Budget in the amount of**
13 **\$348,164.63 (collectively "FY 2021 Department of Education Division of Early**
14 **Childhood Development Head Start Budgets") which are incorporated by this**
15 **reference, in the total amount of \$1,889,334.00 to be funded by federal funds; and**

16 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
17 **reviewed the FY 2021 Department of Education Division of Early Childhood**
18 **Development Head Start Budgets and recommend their approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2021 Department of Education Division of Early Childhood Development Head**
21 **Start Budgets effective November 1, 2020 in the amount of \$1,889,334.00, which**
22 **shall be funded by federal funds.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2021 Department of Education Division of Early Childhood**
26 **Development Head Start Budgets, provided that any amendments or**
27 **modifications shall be submitted for prior approval by the Tohono O'odham**
28 **Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
30 **day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 2,961.9 FOR;**
31 **-0- AGAINST; -0- NOT VOTING; and 213.8 [03] ABSENT, pursuant to the powers vested in the**
32 **Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,**
33 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
34 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
35 **Act of June 18, 1934 (48 Stat.984).**
