11		\$192,904.00 to be funded by the Promoting Safe and Stable Families Program,
12		which are incorporated by this reference for a total amount of \$325,801.00; and

14		reviewed the FY 2021 Department of Health and Human Services Division of Child
15		Welfare Title IV-B Subparts 1 and 2 Budgets and recommend their approval.
