

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Health and Human Services Women, Infants,
and Children Program Inter Tribal Council of Arizona Grant Budget)**

RESOLUTION NO. 20-281

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
8 **review and approval its FY 2021 Women, Infants, and Children Program ("WIC")**
9 **Inter Tribal Council of Arizona ("ITCA") Grant Budget, which is incorporated by**
10 **this reference, in the amount of \$140,115.00, which shall be funded by the**
11 **Nation's general fund pending reimbursement by the grantor, the Inter Tribal**
12 **Council of Arizona; and**

13 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
14 **reviewed the FY 2021 Department of Health and Human Services WIC ITCA Grant**
15 **Budget and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2021 Department of Health and Human Services Women, Infants, and Children**
18 **Program Inter Tribal Council of Arizona Grant Budget effective October 1, 2020 in**
19 **the amount of \$140,115.00, which shall be funded by the Nation's general fund**
20 **pending reimbursement by the grantor, the Inter Tribal Council of Arizona.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation chairperson or any designated official is authorized to administer and**
23 **expend the FY 2021 Department of Health and Human Services Women, Infants,**
24 **and Children Program Inter Tribal Council of Arizona Grant Budget, provided**
25 **that any amendments or modifications shall be submitted for prior approval by**
26 **the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
28 **day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
29 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
