

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Executive Branch Tribal Budgets)

RESOLUTION NO. 20-282

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Executive Branch has prepared and submitted for review and approval its FY**
8 **2021 Executive Branch Tribal Budgets for the period beginning October 1, 2020**
9 **and ending on September 30, 2021, which are incorporated in summary by this**
10 **reference, in the amount of \$94,277,153.55 to be funded from the Nation's general**
11 **fund; and**


12 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2021 Executive Branch**
13 **Tribal Budgets and recommend their approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2021 Executive Branch Tribal Budgets effective October 1, 2020 in the amount**
16 **of \$94,277,153.55, which shall be funded by the Nation's general fund.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
18 **Nation chairperson or any designated official is authorized to administer and**
19 **expend the FY 2021 Executive Branch Tribal Budgets, provided that any**
20 **amendments or modifications shall be submitted for prior approval by the**
21 **Tohono O'odham Legislative Council**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
23 **day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
24 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
25 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
26 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat.984).**
