

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2021 Tohono O'odham Nation Health Care Budgets)**

**RESOLUTION NO. 20-283**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Tohono O'odham Nation Health Care ("TONHC") Governing Body, subject to  
8 the review and approval by oversight committees and Legislative Council, was  
9 delegated the authority to review and approve all TONHC budgets and budgets  
10 expending health self-governance funds, including budgets expending such  
11 funds for supporting programs with other Nation's departments (Tohono  
12 O'odham Nation Health Care Governing Body Bylaws, Section 9403(A)); and

13 **WHEREAS,** the Tohono O'odham Nation Health Care and Department of Information and  
14 Technology, have prepared and submitted for review and approval its FY 2021  
15 Tohono O'odham Nation Health Care Budgets, for the period beginning October  
16 1, 2020 and ending on September 30, 2021 (collectively, "FY 2021 Tohono O'odham  
17 Nation Health Care Budgets") and as identified in the FY 2021 Tohono O'odham  
18 Nation Health Care Budgets Schedule, which is attached and incorporated by this  
19 reference, in the total amount of \$134,478,610.36:

20 Tohono O'odham Nation Health Care \$ 132,577,557.41

21 Department of Information & Technology-Third Party \$1,901,052.95; and

22 **WHEREAS,** the Governing Body, pursuant to the Governing Body Bylaws at Section 9301(d)(1)  
23 and the CMS conditions of participation found at 42 CFR Part 482(d)(1), is legally  
24 responsible for an institutional plan that "must include an annual operating  
25 budget that is prepared according to generally accepted accounting principles  
26 and the Nation's budgeting process"; and

27 **WHEREAS,** the TONHC Governing Body has reviewed the FY 2021 Tohono O'odham Nation  
28 Health Care Budgets and recommends approval; and

29 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
30 reviewed the FY 2021 Tohono O'odham Nation Health Care Budgets and  
31 recommend their approval.

32 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
33 FY 2021 Tohono O'odham Nation Health Care Budgets effective October 1, 2020 in  
34 the total amount of \$134,478,610.36, which shall be funded by the Indian Health  
35 Service and third party revenues.



1 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
2 **Nation chairperson or any designated official is authorized to administer and**  
3 **expend the FY 2021 Tohono O'odham Nation Health Care Budgets, provided that**  
4 **the Governing Body shall approve any amendments or modifications, subject to**  
5 **final approval by the Tohono O'odham Legislative Council.**

6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>**  
7 **day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**  
8 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
9 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
10 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
11 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
12 **18, 1934 (48 Stat.984).**
