RESOLUTION NO. 20-286

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article II,**
3 **Sections 1 and 2 and Article VI, Section 1 (b) of the Constitution of the Tohono**
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications and**
7 **making recommendations to the Legislative Council regarding the eligibility of**
8 **applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

9 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**
10 **O'odham Legislative Council shall determine whether an application is approved**
11 **for membership and its determination, along with the resolution number and**
12 **date of enactment, shall be provided to the applicant; and**

13 **WHEREAS, the Enrollment Program has received the official documents showing the legal**
14 **name changes of enrolled members due to a variety of reasons, such as marriage,**
15 **divorce, or legal adoption; and**

16 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 74-81, 127-83,**
17 **164-83, 102-84, 91-454, 94-109, 94-262, 95-139, 96-182, 97-078, 97-256, 97-480, 98-**
18 **034, 98-123, 99-633, 02-280, 05-148, 07-075 and 19-445 be amended to reflect the**
19 **amended names for the members identified in the September 2020 Amended**
20 **Enrollment Resolution Summary, which is incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
22 **Nos. 74-81, 127-83, 164-83, 102-84, 91-454, 94-109, 94-262, 95-139, 96-182, 97-078,**
23 **97-256, 97-480, 98-034, 98-123, 99-633, 02-280, 05-148, 07-075 and 19-445 are**
24 **amended upon the effective date of those resolutions to reflect the legal name**
25 **changes for the members identified in the September 2020 Amended Enrollment**
26 **Resolution Summary.**

28 **day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**

30 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**
31 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
32 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
33 **16 of the Act of June 18, 1934 (48 Stat.984).**
